- Examine the details of the project proposal and decide the eligibility, nature as well as quantum of incentives admissible after cost benefit analysis of the project taking into account the benefits to the State.
- Recommend the proposal to the State Cabinet for consideration and discharge all other functions to facilitate the project for timely implementation.






